



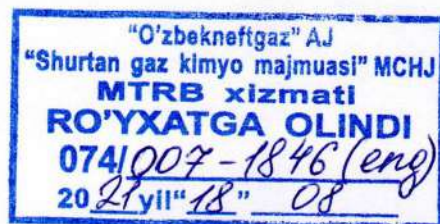

1. DESCRIPTION OF THE GOODS

1.1 Buffer Solution.

2. PURPOSE OF PURCHASING

2.1. The buffer solution with pH allows calibration and adjustment of pH-meters.

Buffer solutions with a certain stable concentration of hydrogen ions, which is a mixture of a weak acid and its salt of a weak base and its salt used to reproduce and maintain numerical pH values in solutions of different composition.

3. BASIS OF PURCHASE

3.1. Application from The instrumentation and automation shop for 2022.

3.2. Financing is carried out at the expense of own means of "Shurtan GCC", LLC (Uzbekneftegaz JSC).

5. COMPLETE SET

5.1. The package shall be in accordance with the factory packaging.

7. REQUIREMENTS FOR THE PRODUCT

7.1 The supplied products shall be manufactured in the year of delivery or preceding it and not previously used.

7.2. In accordance with the technical requirements of the current standards.

7.3. The products shall have certificates of conformity and certification test reports confirming the declared characteristics, accompanied by installation, adjustment and operation documentation.

7.4. All accompanying documentation shall be in Russian and shall be provided to the customer together with the products supplied.

7.5. The supplied equipment shall be designed for continuous operation 24 hours a day, 7 days a week under specified conditions during the specified service life.

7.6. The equipment shall be marked in Russian and have clear designation. The manufacturer, batch number and date of manufacture are also indicated. Marking shall be maintained for the entire service life of the supplied equipment.

7.7. The options proposed by the participant for technical parameters and characteristics of equipment and materials not specified in the TA are agreed additionally.

8.1. Insurance of the goods is made at the expense of the Supplier.


9. GUARANTEE
